RULES AND REGULATIONS

1. The contest entry fee is \$20 for Knee Deep Club Members and \$25 for non-members (\$20 entry + \$5 non-member fee), and must be submitted with the official contest entry form below. The contest will begin at 5:00 AM on Saturday, October 10th, and will end at Noon on Sunday, October 11th.
2. Mailed-in entries must be received by the Club by Friday, October 9th, regardless of the postmark. In-person Entries can be made at either official Knee Deep Contest Weigh Station until 8:00 AM on Saturday, October 10th. **No one will be allowed to register for this contest after this time. NO EXCEPTIONS.**
3. **CASH PRIZES** will be based on an 80% payback of entry fees for the three (3) heaviest Walleye weighed in.
4. **BONUS PLAN** participants for this contest will have their cash prizes increased by 25%
5. **GIFT CERTIFICATES:** The anglers catching the 4th, 5th and 6th heaviest Walleye will receive a \$20 gift certificate to Dow's Boat Rental in Nolan's Point, Lake Hopatcong, NJ.
6. Top finishers will be based on weight and any ties will be broken by which Walleye was weighed in first.
7. A contestant may only win one prize. If any of the prizes are not awarded, the prize money will go to the club's stocking fund.
8. **Only Walleye caught in Lake Hopatcong may be entered.**
9. All persons in a boat must be entered in the contest in order to qualify for prizes. Contestants may fish any or all parts of the contest.
10. All fish must be weighed-in during contest hours. No fish will be weighed in after Noon on Sunday, October 11th.
11. Any disputes must be resolved at the time of the weigh-in. The decision of the Contest Committee will be final and binding. The Weigh Master has the right to retain, cut open or inspect any fish.
12. The Official Contest Weigh Stations are **DOW'S BOAT RENTAL** at Nolan's Point and **LAKE'S END MARINA** on Lakeside Blvd. in Landing.
13. **TAKE A KID FISHING:** A contestant may enter a child under 16 years of age in this contest for a \$5 entry fee. The child with the heaviest Walleye will win a rod and reel combo. Ties will be broken by which Walleye was entered first.

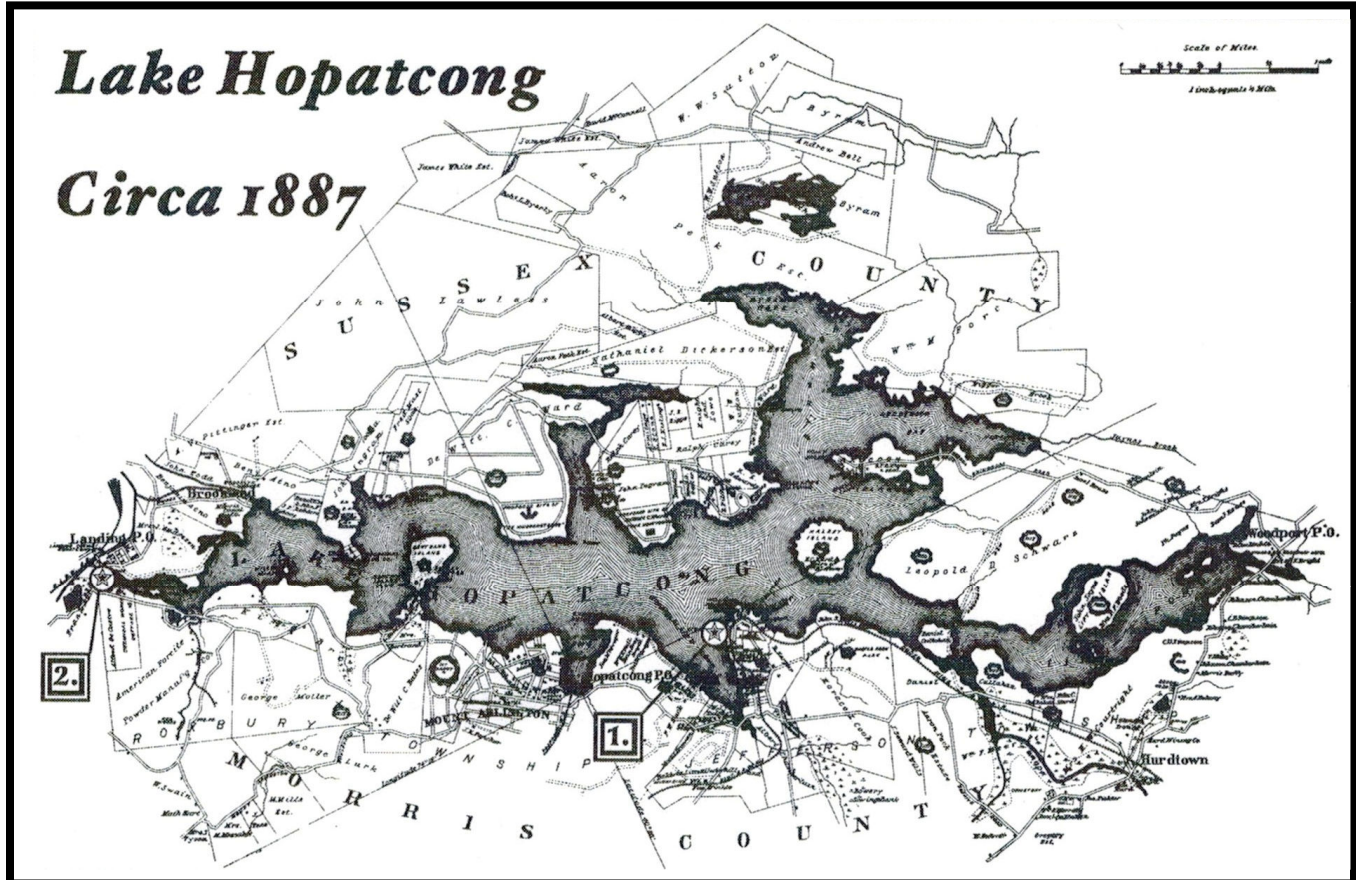
